1.1 – Curriculum Planning and Implementation

1.1.1 – Institution has the mechanism for well planned curriculum delivery and documentation. Explain in 500 words

The objective of preparing the students for success in educational pursuits as mentioned in the mission is achieved through the effective implementation of the curriculum and co-curricular activities so that the students would be able to face the present challenging world as empowered citizens through the effective implementation of the curriculum by following the under mentioned approaches: • Discipline-based learning with the support of a teaching plan • Student-centric conventional face-to-face teaching-learning process • Student-

communication service and social media platforms • Value-Based Education • Promotion of co-curricular and extra-curricular programmes The above objectives are achieved through adopting a multi-pronged phase-wise strategy. At the institutional level at the beginning of every academic session, Academic Committee under the guidance of Teachers' Council frame strategies to develop the Academic Calendar for the year which serves as an action plan for the implementation of curriculum as well as a schedule of co-curricular and extracurricular activities. At the beginning of each session and examination, Teachers' Council in different meetings chaired by the Principal, discusses in detail and evaluates the session details and examination-oriented tasks. The Academic Committee, comprising of senior faculty members from different disciplines is formed every year to look into the academic aspects from time to time as per the Academic Calendar. At the departmental level, every department arranges meetings of the faculty members before the commencement of classes in each session where the course syllabi are distributed as teaching assignments among the teachers. Teaching plans are prepared by the departments which comprise lecture hours, topics to be taught and other co-curricular activities to be conducted during the session. The faculty members are advised to prepare and chalk out their teaching plans for the term to complete the syllabi within the stipulated time. If for any reason, a faculty fails to finish his/ her syllabi within the stipulated time, he/ she arrange extra classes for his/ her subject. The progress is monitored by the Head of the Department which is also reported to the Principal from time to time. In the individual level, the teaching plans are executed with different teaching methodologies for the courses. Advanced methods of teaching are followed in the classroom besides lecture methods which include the use of presentations, models, assignments, interactive discussions with students, practical tests and internal assessment to build up a better appreciation of the subject. Regarding documentation, each and every department keeps the records of attendance, examination marks apart from the academic section of the college. During the pandemic lockdown time, the faculty members of the institute continued the teaching-learning process by reaching out to the students through free video-communication services like Google Meet, Zoom, WebEx Meet etc. as well as social media platforms like WhatsApp and Facebook. All class tests, internal and University examinations were conducted online with the use of Google Forms, Google Classrooms and email correspondence with the students. Institutes organized training programs for the faculty members with that effect.

Feedback Obtained

The IQAC of the college has evolved its own system of feedback from the target groups: All students of the College are provided with a structured Google Form questionnaire with pre-set grade points to access and give their opinions on the various aspects of the teaching of individual teachers. Student Satisfaction Survey on the overall performance of the institute and student's concept of the relevance of the course is also undertaken online with the use of Google Form questionnaire. This is an open exercise where individual students are encouraged to give their feedback for which the identity of the individual student is kept confidential. Similarly, a structured questionnaire is circulated among the teaching faculty where their valued opinions and ideas on various aspects of the curricula, teaching-learning processes, facilities

available in the College along with shortcomings are registered with specific and overall observations for future remedy. These two responses are studied in a corroborative manner. The student and teacher feedbacks are analyzed and the findings are communicated to the Head of the institution for overall remedial actions that the college may take. 2.5.2 - Reforms initiated on Continuous Internal Evaluation(CIE) system at the institutional level (250 words)

The college holds three centralized examinations for each semester, viz., two sessional examinations and the final examination. These examinations are conducted for each semester. Results of these examinations are published centrally. Answer scripts are shown to the students and the pattern of evaluation is explained. Model answers are discussed for the benefit of the

students. Class tests and tutorial classes are held regularly by the departments in order to assess students' knowledge and skills. Besides these tests, students' presentation in seminars, group discussions, projects in the relevant subjects, which also help in monitoring students' performance prior to the university examinations. Examination Committee of the College based on their logistics, prepare the time frame for conducting the sessional examinations (examination schedule, evaluation schedule, result announcement schedule, marks submission schedule). This enables the examiners and examinees to know the time frame for completion of the process of evaluation and results. Regular notification by the Principal regarding examination is also a part of the teaching-learning-evaluation process of the institution. The Schedule of the college and university examinations is highlighted in the Prospectus at the beginning of the session as guided by the affiliating university. During the pandemic lockdown, all examinations were conducted online by the College. Thus, the systematic planning, organization and implementation of the teachinglearning-evaluation process are done within the total scheme of the university schedule as these are very much necessary for the academic upliftment of the college.

The HOD, in consultation with their respective faculty members, designs the class loads of individual teachers, plans for holding departmental examinations, oversees the working reports of the non-teaching staff and guest lecturers. Several committees are formed to disburse of academic and non-academic matters and these committees work independently. The administrative wing works through office headed by the Office Superintendent who monitors office work. 7.1.7 – Initiatives taken by the institution to make the campus eco-friendly (at least five)

1. Plantation programmes are organised on the occasion of Vana Mahotsav and on other occasions where the teachers, as well as the students, participate to make the campus more green. 2. NCC and NSS volunteers frequently arranged for cleaning of campus through programmes like Swachat Bharat Abhiyan with emphasis on proper segregation and disposal of campus waste. 3. To increase awareness

about decreasing the use of non-renewable energy sources, the students are encouraged not to use motorbikes but to travel to the college on bicycles 4. To sensitize the students about energy misuse students are encouraged for best practices like switching off fans and lights of the rooms not in use by putting posters with the message at appropriate places. 5. Students and sensitized about the misuse of water on the campus and encouraged to practice a zero waste mindset for tapwater.

7.2 - Best Practices

7.2.1 – Describe at least two institutional best practices

Details of two best practices implemented by the institution during AY 2019-20 Best Practice- 1 1. Title of the practice: Playing of National Anthem on the campus on all working days at a fixed time through Public Address System 2. The context that required the initiation of the practice: The spirit of patriotism is a great unifying force for the youth and at the personal level also it saves the youth from many distractions and what better way to instil it than the National Anthem. The practise becomes more effective when done in an assembly. Thus, the present practice was initiated to help the students focused on achieving their goals in unison with the national goals and aspirations. 3. Objectives of the practice: The objective of the practice is to instil a sense of patriotism among students, to help save students from distractions and promote unity. 4. The Practice: The practice consists of playing the National Anthem every working day at the fixed timing of 12.15 PM through public address system loudspeakers placed at suitable places on the campus. When the anthem is played all activity on the campus is temporarily stopped and everyone stands in attention and sings along. To alert everyone a small hooter is played just before the starting of the Anthem followed by a brief recorded announcement to the same effect. 5. Obstacles faced if any and strategies adopted to overcome them: Obstacles faced regarding implementation of the practice consist of the non-availability of suitable public address system arrangements for playing the anthem so that it is clearly audible everywhere as well as fixing a suitable time for the same. These obstacles are overcome with the purchase and installation of public address system components along with the installation of the same at suitable places on the campus. It is not possible to have an assembly in the college due to a large number of students and varied class starting times, the college being a multi-faculty college. The time of 12.15 PM was chosen as according to the class hours of different courses this time the college should have the greatest number of students present on the campus. Some necessary changes were also made in the class hours so that the anthem is played in the gap between the two classes as far as possible. 6. Impact of the practice: The practice has a positive impact on the students and staff alike. Students, as well as staff members, sing the anthem along with full patriotic fervour. Doing such an activity together every day at a fixed time has also promoted a sense of unity and togetherness among the students and staff alike on the campus. 7. Title of the practice: Initiating the students to Green Practices so as to transform the campus to a "Green Campus" 2. The context that required the initiation of the practice: During a Preliminary Green Audit of the institution on the parameters of Waste management, Energy Use and Water Use by the IQAC it was observed that the awareness level of the students on such green practices

was not up to the mark. This is resulting in littering, misuse of electricity and water on the campus which is both aesthetically and financially detrimental to the institution. Thus, the present practice was initiated to train the students on Green Practices so as to transform the campus into a "Green campus" 3. Objectives of the practice: The objective of the practice is to initiate the students to "Green Practices" like no littering waste disposal, zero misuses of tap water and electricity etc. so as to convert the campus to a "Green one' 4.

The Practice: To initiate the students to Green Practices a number of programmes were organized by the College under the NSS unit activities during the first half of the year, before the lockdown period. The activities consist of cleaning activities in the campus under Swachh Bharat Abhiyan, Awareness Programme featuring talks and hands-on activities on Plastic and other solid waste management, Fit India Plog Run etc. To sensitize the students about the misuse of water and Electricity on the campus, posters emphasizing the proper use of the resources were pasted at appropriate places on the campus. Due emphasis is also given to plantations on the campus by organizing plantation drives on the occasion of Vanamahotsab. The students are involved in caring for the existing trees and plants. 5. Obstacles faced if any and strategies adopted to overcome them: No obstacles were faced as such regarding the implementation of the practice. 6. Impact of the practice: The impact of the practice is to be seen in the greenery of the campus. The students have grown much conscious about the proper use of tap water and electricity. They are not keeping taps running for no use and fan, lights on in an empty class. The campus is now free of littering and with a proper plan of segregation of waste in biodegradable and non-biodegradable components at source and safe management and disposal of the campus solid waste. 7. The College has a 50 seater ST Boys Hostel to help the neediest Schedule Tribe students who cannot afford to rent a house to carry on with their studies in the College. As for the female students, the institution provides separate toilet and common room facilities so as to make their college time comfortable.
